## **REACH declaration of conformity**

Declaration on EU Regulation (EC) No. 1907/2006 on registration, Evaluation, approval and restrictions of chemical substances

According to Regulation (EC) No. 1907/2006 (REACH), which came into force on June 1, 2007, elero GmbH counts as a downstream user. elero GmbH only sells non-chemical products and is therefore not obliged to register or report to the European Chemicals Agency (ECHA). elero GmbH expects its suppliers to act in accordance with REACH requirements.

No substances are used in elero GmbH's products that are listed in Annex XIV of Regulation (EC) 1907/2006 and require approval by ECHA. All restrictions of Annex XVII of Regulation (EC) 1907/2006 are also complied with.
